**Spousal Bursary** – A husband and wife who are both studying are entitled to – \$725 (*Seminary*) or \$925 (*UC*) per academic year.

**Family Bursary** – For families when more than one full-time student from the same household is enrolled at the same time, each sibling will be awarded - \$600 (*Seminary*) or \$800 (*UC*) per academic year.

**Seniors Bursary (\$900 for full-time senior student, \$450 for part-time senior student)**

Seniors over 60 years of age who are studying full-time at Tyndale are eligible to receive \$900 per academic year.

**ACSI Member Tuition Bursary (\$900 for a full time student, \$450 for a part-time student)** – Full-time staff members of the Association of Christian Schools International (ACSI) who are studying at Tyndale are eligible to receive up to \$900 per academic year. A supporting document confirming employment is required.

**IVCF / YFC / P2C Member Tuition Bursary** – Full time staff members of the Inter-Varsity Christian Fellowship (IVCF) / Youth for Christ (YFC) / Power to Change (P2C) who are studying at Tyndale are eligible to get 25% off the tuition fee. A supporting document confirming employment is required.

**Alumni Awards** - UC Alumni students who are enrolled full-time at the Seminary are eligible for \$250 per course per academic up to a maximum of \$2,000 per year for 3 years of study.

**Children of Alumni Awards (\$500)** – Awarded to first 5 first-year full-time students. Student must be a dependent of a parent who was a former student of Tyndale University College & Seminary (or OBC/OTS). Parent must have completed equivalent of one full-time year at Tyndale.

**Timothy Scholarship (\$500)** – Awarded to first 6 first year full-time students. Student must be a dependent of a parent employed full-time by a church, mission organization, or a Christian elementary or high school.

**Christian Camp Service Award (\$500)** – Awarded to first year full-time students. Student must be working full-time at a partnering Christian camp for the summer leading up to their first academic year at Tyndale. A supporting document confirmation employment is required.
