SEMESTER 1-3 PAYMENT PLANS (the \$350 fee for Extended Healthcare Benefits is included in the first installment; please submit your payment plan selection using the [online form](#)):

- I will apply for Government Student Aid\*.** [All supporting documents must be submitted no later than June 30, 2023]. I understand that I am responsible for paying any tuition fees not covered by the student aid. I will pay the outstanding balance in 4 installments: \$7,154 (\$7,556 for FSL) on Aug 1/23, and \$6,804 (\$7,203 for FSL) on Nov 1/23, Feb 1/24, May 1/24.
- I will pay the outstanding balance in 4 installments\*:** \$7,154 (\$7,556 for FSL) on July 1/23, and \$6,804 (\$7,203 for FSL) on Oct 1/23, Jan 1/24, Apr 1/24.
- I will pay the outstanding balance in 12 installments\*:** \$2,618 (\$2,754 for FSL) on July 1/23, and \$2,268 (\$2,401 for FSL) monthly installments on the first day of the month beginning on Aug 1/23 and concluding June 1/24.

**\*Outstanding balance is subject to monthly interest at 12% per annum**

#### PAYMENT METHODS:

- Online Payment through a Canadian financial institution:** Please add "Tyndale University" as a payee to your "bills" list. The account number will be your Student ID number. If your student ID is shorter than 9 digits, please add '000' in front of your student ID number. ex. 000123456. Please note that online payments take 2 business days to reach our bank, please allow for sufficient processing time.
- Cheques:** Please send a cheque by mail or drop off a cheque at the campus Reception. (please make the cheque payable to "Tyndale")
- Visa or MasterCard:** Please submit your payment at <https://pay.tyndale.ca>. A 2% charge will be added to all credit card transactions to cover transaction costs.

### Which financial institutions can I make online payments from?

### When will the government student aid applications be available?

### If I am applying for government student aid for semesters 1-3, do I need to apply again for semester 4?

Yes, you will complete the 2022-2023 application for semesters 1-3. When the 2024-2025 application becomes available in Spring 2024, you can apply for government student aid for semester 4.

## MISCELLANEOUS

### Will I get a notification about the payment deadlines?

Yes, you will receive a reminder in your MyTyndale email account approximately 2 weeks before the payment deadlines. These emails are sent as a courtesy and must not be relied upon. It is the responsibility of the student to adhere to the deadlines listed in this form.

### When can I expect my income tax receipt?

Tuition tax receipts (T2202 & T4A) for the calendar years 2010-2022 are available through your MyTyndale account. 2023 tax receipts will be available on MyTyndale in February 2024.

**Will I receive a refund if I drop out of the program?**

The refund amount will be calculated for each course based on the percentage of completion and the approved withdrawal date.

Deadlines	Refund
Less than 20% of course duration	100%*
Less than 30% of course duration	80%**
Less than 40% of course duration	70%**
Less than 50% of course duration	60%**
50% of course duration	50%**
More than 50% of course duration	0%**

\* Drop Fee of \$100 per course will be charged.

\*\* Refund % applies to Tuition, Resource Fee, Student Activity Fee and Graduation Fee. Administration fee is not refundable.
