New students starting in May 2024

Deduct the \$500 deposit from your tuition balance and choose one of the payment options.

- 1. Pay the outstanding balance in full by May 1/24*.
- 2. Pay the outstanding balance in 3 installments by the following dates: May 1/24, Sept 1/24, and Jan 1/25.
 - *Students with an outstanding balance as of May 1/24 will be automatically enrolled in an installment plan (Installment fee applies).
- 3. Apply for Government Student Aid. Students are responsible for paying any tuition fees not covered by the student aid funding. All outstanding fees are due by Jan 1/25 (Installment fee applies). For the OSAP Tip Sheet, please refer to our website.

PAYMENT METHOD:

- 1. Online Payment through a Canadian financial institution (preferred payment method to keep Tyndale's processing fee low): Please add "Tyndale University" as a payee to your "bills" list. The account number will be your Student ID number. If your student ID is shorter than 9 digits, please add '000' in front of your student ID number. ex. 000123456. Please note that online payments take 2 business days to reach our bank, please allow for sufficient processing time.
- 2. Visa or MasterCard: Please submit your payment at https://pay.tyndale.ca. (2% charge will be added to all credit card transactions)
- **3. Cheques:** Please send a cheque by mail or drop off a cheque at the campus Reception. (please make the cheque payable to "Tyndale")

How do I access my MyTyndale account to view my statement?

- 1. Please visit www.mytyndale.ca.
- 2. Log in with your MyTyndale username and password. If you do not know your password, please reset it online.
- 3. Click on the Financial Services tab (near the top of the page).
- 4. Click My Statement (on the left-hand side of the page).
- 5. Click View My Statement (on the left-hand side of the page) to view your statement.

ONLINE PAYMENTS (VIA A CANADIAN BANK ACCOUNT)

Which financial institutions can I make online payments from?

You can pay for your tuition fees online if you bank with one of the following financial institutions: CIBC, TD Canada Trust, Bank of Montreal, Scotiabank, Royal Bank, HSBC, Simplii Financial, or Tangerine.

I am unable to register "Tyndale University" as the payee.

Some banks do not have Tyndale registered with the exact name as the one mentioned above. Please search for "Tyndale" and our full name will show up.

GOVERNMENT STUDENT AID

If you are applying for government student aid (e.g., OSAP), please complete your application and submit all required documents by May 1, 2024. Please use the 2023-24 application with May 1, 2024, as your program start date. Please notify Student Financial Services when you apply for government student aid, so we can help monitor the status of your funding. We encourage you to apply for student aid as early as possible, as it can take 8-10 weeks to process. Please note that if you are waiting for your student aid and have not received it by January 1, 2025, you will still be responsible for clearing your tuition balance by the final payment deadline on January 1, 2024.

MISCELLANEOUS

Will I get a notification about the payment deadlines?

Yes, you will be emailed a reminder for the payment deadlines to your MyTyndale email account approximately 1-2 weeks before the deadline. These emails are sent as a courtesy and must not be relied upon. It is the responsibility of the student to adhere to the scheduled deadlines. Deadline dates can be found in your MyTyndale account.

When can I expect my income tax receipt?

Tuition tax receipts (T2202 & T4A) for the calendar years 2009-2023 are available through your MyTyndale account. 2024 tax receipts will be available on MyTyndale in February 2025.
