### I. COURSE DESCRIPTION

Examines Second Corinthians to discover its profound teaching on the nature of Christian ministry. Issues such as discipline and forgiveness, suffering and service, glory and humility, generosity and rewards are all topics that are discussed. Helps students discover ways in which to minister more effectively to the Body of Christ and the world in which we live.

### **II. LEARNING OUTCOMES**

At the end of the course, students will be able to:

- 1. Understand the social and historical background of Second Corinthians and trace through its literary structure,
- 2. Identify the major ministry issues the apostle Paul deals with, such as legitimacy of his apostleship, church discipline, sin & forgiveness, suffering as a servant of God, etc.,
- 3. Articulate and appreciate Paul's self-understanding and Paul himself as a person: emotionally, physically, interpersonally, and spiritually.

### **D. GUIDELINES FOR INTERACTIONS**

Therefore, we ask our students to be charitable and respectful in their interactions with each other, and to remain focused on the topic of discussion, out of respect to others who have committed to being a part of this learning community. ### E. ASSIGNMENTS AND GRADING

- 1. Class Participation (20%). Students are expected to demonstrate that they have read the required reading prior to each class and participate actively and constructively in class.
- 2. Bible Knowledge Test (20%). Students will be tested on their knowledge of the content of Second Corinthians. Questions include: fill in the blanks, true or false, identification of the verse location, and short questions. Date: Oct 19, 2023.
- 3. Biblical Exposition Essay (30%). The exposition will base on a passage from 2 Corinthians 1-6, selected by the student and approved by the Instructor. The student is expected to demonstrate knowledge of the text based on the course materials and class instruction and relevance for Christian ministry. Length: 5-10 pp. Due: Nov 2, 2023.
- 4. Theological Essay (30%). The paper should be a substantial piece of theological analysis in response to a key argument of 2 Corinthians. A list of essay questions will be distributed during the first month of class: you will need to answer only one of these questions in your essay.

The essay should not simply report, summarize, or review class materials. It should, rather, concentrate upon theological (method or history) rather than biblical questions. It should demonstrate thoughtful reflection, analysis, and should embody a conceptual argument in which various angles of the questions are explored in fairness and at length. Length: 5-10 pp. Due: Dec 7, 2023 (last class).

# F. EQUITY OF ACCESS
