I. COURSE DESCRIPTION

Students complete a major research proposal in the field of Counselling and Psychotherapy that demonstrates their ability to formulate a research question, use existing peer reviewed research studies to develop a well-structured literature review and methodology section, and draft an ethics proposal.

Prerequisite: COUN 0680 Research Methods in Counselling, COUN0601 & 0602 Pre-Internship Skills Lab I & II; COUN0772 & 0774 Theories and Methods I & II. MA Clinical Counselling majors only.

II. LEARNING OUTCOMES

At the end of the course, students will be able to:

1. Develop an original testable research question
2. Write a comprehensive literature review
3. Complete a Research Ethics Board (REB) ethics approval process
4. Design a proposed methodology section that is scientifically sound
5. Prepare an APA formatted research proposal including: Introduction, Methods, proposed Data Analysis, and Discussion sections
6. Provide a critical reflection on the integration of the research topic with a Christian framework
7. Present an analysis of the importance and contribution of the research topic to the field of Marriage and Family Therapy and Psychotherapy

C. ASSIGNMENTS AND GRADING

1. Literature Map Presentation. 5% of final grade. Due: Oct 6.

The student will give a presentation of the Literature Review Map consisting of the broad research topic (problem), key constructs, anchor studies, gaps in the literature, and rationale for the current research project.

2. Research Proposal with Annotated Bibliography. 10% of final grade. Due: Oct 20.

The student will submit a Research Proposal that outlines the general overview of the research topic, including an annotated bibliography consisting of a minimum of 10-15 key references that will be used to develop the literature review section of the thesis project. Each source will include the citation (in proper APA style) and a brief annotation of the study.

3. Draft Assignments: Literature Review Draft (20% of final grade. Due: Nov 10), Methodology Draft (10% of final grade. Due: Nov 24).

The drafts for the Introduction (Literature Review, Research Question, and Hypotheses) and Methods Sections (Methodology) should strictly follow APA style for in-text citations, references, figures, tables, etc., as well as demonstrate a strong grasp of the research process and topic. The student is required to hand in a soft copy of the drafts at the determined dates throughout the semester for discussion and feedback with the supervisor. Failure to submit the assignments on their due dates will result in deductions to the final grade.

4. Integration Reflections and Empirical Findings. 5% of final grade. Due: Nov 17.

The student will give a presentation on Integration reflections and findings drawing upon 5-7 empirical research studies that intersect the research topic or key constructs with theological constructs.

5. Research Ethics Board (REB) Application: 5% of final grade. Due: Dec 1.

The student will prepare a full ethics application for the Tyndale Research Ethics Board which will be reviewed by the professor for accuracy and pre-approval.

6. Research Project Presentation: 5% of final grade. Due: Dec 8.

Students will present their research project. Current Tyndale Counselling students may be invited to attend, if interested.

7. Final Research Report: 40% of final grade. Due: Dec 15.

The student will hand in a final version of the research project that clearly articulates the research question, the comprehensive literature review, a sound methodology, and proposed data analysis following the guidelines of APA. In addition, a discussion section will be included that provides a critical integration of the research topic with a Christian framework as well as reflections on the implications of this project in the field of psychotherapy research. The final research thesis project will be 30-40 pages, double spaced, 12-font (not including cover page and reference section).

Upon submission, you will receive a summary that includes your submitted files along with a similarity report generated by Turnitin. Please be aware that Turnitin can also detect AI-generated content from tools like Grammarly, so students should be mindful of when using such software. Research Ethics

All course-based assignments involving human participants requires ethical review and may require approval by the [Tyndale Research Ethics Board \(REB\)](#). Check with the Seminary Dean's Office (seminaryoffice@tyndale.ca) before proceeding.

Late Papers and Extensions Policy

All papers and course assignments must be submitted by the due dates indicated in the course syllabus. Unless the instructor already has a policy on grading late papers in the course syllabus, grades for papers submitted late without an approved extension will be lowered at the rate of two-thirds of a grade per week or part thereof (e.g., from "A+" to "A-," from "B" to "C+"). Please note that some programs, such as cohort-based or intensive courses, may follow a different policy due to the nature of the program.

Faculty may not grant an extension beyond the last day of exams for the semester. Requests for extensions beyond this date must be addressed in writing to the Registrar by filling out the [Extension Request Form](#). The application will be considered only in cases such as a death in the family, medical emergency, hospitalization of oneself or immediate family member or prolonged illness requiring treatment by a physician. Factors such as assignments for other courses, holidays, and technology-related difficulties are insufficient grounds for requesting an extension.
