I. COURSE DESCRIPTION

Preparing missional leaders requires careful examination of the ideologies and cultural milieu of contemporary society. This course examines the main features of the postmodern culture, the meaning of faithfulness to the gospel, the good news of God's salvation, and the nature and mission of the church. The church's witness and service to the world is studied not as one of the functions of the church but as its essential nature. Missional leadership takes seriously the calling of all God's people to minister in every sphere of life as faithful witnesses to the gospel of salvation.

II. LEARNING OUTCOMES

At the end of the course, students will be able to:

- A. Apply an in-depth biblical-theological interpretation of the gospel.
- B. Theologically examine the relationship between the gospel, the kingdom of God and the church.
- C. Articulate the nature of the people of God as a sign, instrument, and foretaste of the kingdom of God.
- D. Analyze how culture shapes our understanding of the gospel, church, and ministry.
- E. Develop categories and concepts for socio-cultural analysis of specific ministry and vocational contexts.
- F. Identify major dynamics of Canadian culture, including an exploration of the meaning and implications of late/post-modernity for the church's witness and service.
- G. Evaluate how the gospel and church can address a multiethnic, pluralistic culture.
- H. Integrate theological insights with socio-cultural analysis in developing a theology to inform the church's response to its local context.

D. ASSIGNMENTS AND GRADING

All assignments require careful completion of the readings in conjunction with consideration of their relationship to the ideas presented in the lectures. It is expected that students will complete the assigned reading **prior** to the scheduled lecture for the week.

Detailed information for each assignment including rubrics will be posted on the course resource page.

1. Modernity Paper: Due on Friday, October 20, 2023; 25% of final grade.

This is a 1250-word paper on the culture of modernity and its impact on the church. Papers will respond to the question, "What are the main features of modernity, and how do they impact the life and ministry of the church in your context?"

2. Online Discussion Forums: Weeks 2, 4, 6, 8, and 10; 20% of final grade.

Online discussions are opportunities to critically reflect on the lectures and readings, share ideas with your peers, and benefit from the ideas presented by your colleagues. The aim is to make this a collaborative learning experience that functions as a prototype of how the church as the body of Christ is intended to operate.

NOTE: Posting to forums on time is crucial for facilitating discussion and giving your peers enough time to read and respond to your work. Posts submitted late will only be eligible for half credit (i.e. "D" grade).

3. Class Group Work Participation: Weeks 2, 4, 6, 8, 10, and 12; 10% of final grade.

On the weeks listed above, a portion of class time will be dedicated to work in groups. Group work provides an opportunity to engage the course material critically in collaboration with your colleagues. The purpose is to allow you to experience how our community's cross-cultural and denominational backgrounds can help to broaden your perspective on areas where the gospel needs to challenge us, the church, and the society we live in.

4. Final Integration Paper: Due on Friday, December 8, 2023; 45% of final grade.

This is a 3000-word final paper that integrates central ideas from the readings and lectures with your own ministry context. Papers should respond to the question, "What is the role of the church in communicating the gospel faithfully in postmodern culture, within your context?" The paper should draw on the course material including all assigned readings.
