## **I. COURSE DESCRIPTION**

This course will explore the ministry of pastoral care in times of grief and loss. We will seek to understand a biblical and theological approach to death and dying as well as the psychological dynamics of the grief process. In addition various ethical issues such as living wills and end of life care, will be explored to help the student become more conversant with the issues that pastors must regularly address.

The material will be presented through lectures, group discussion, film reviews and field trips.

## **II. LEARNING OUTCOMES**

1. To become familiar with the theological understanding of death from a Christian perspective
2. To explore various psychological responses to death
3. To become familiar with some of the ethical and legal issues that arise when someone is dying
4. To be able to respond in an effective manner to those who are dying and to those who are grieving their losses.

### **B. ASSIGNMENTS AND GRADING**

#### **1. Attendance –Participation**

## **3. Written Papers:**

a. Each student will submit a typewritten response to the personal reflection questions. (20%) Due Date: Oct. 1, 2012

b. View the movie “[Million Dollar Baby](#),” and respond pastorally to the questions raised in the case study. It is essential that you substantiate your responses. (25%) Due Date: Nov. 12, 2012.

c. Write a research paper on the grieving practices of a particular cultural or people group. The paper is to be approximately 10 pages in length. (25%) Due Date: Dec. 03, 2012

## **C. GENERAL GUIDELINES FOR THE SUBMISSION OF WRITTEN WORK**

### **1. Late Papers**

There is a 10% penalty per week for all late papers. Requests for extensions are granted only in cases of illness, which require a medical certificate, or death in the family.
