## Research Support Fund: Accountability and Public Acknowledgment

# Definition of the indirect costs of research, along with concrete examples of the types of expenses incurred by the institution in managing the research funded by the three federal research granting agencies:

Indirect costs of research are the operational costs that underpin an institution's research activities (i.e., heating, lighting, ethics reviews, facilities for animals used in research, management of intellectual property, environmental assessment and safety compliance). The services that give rise to indirect costs are institutionally based and are not specific to individual research grants (Social Sciences and Humanities Research Council (SSHRC)).

The Research Support fund received by Tyndale University helps sustain a strong research environment and supports partnership with community researchers in the region. Costs associated with the preparation of research grant proposals, administration of research grants, the preparation of reports, and research planning are also included in the indirect costs.

#### Description of the Research Support Fund program, including a link to the program's website:

The Research Support Fund assists Canadian postsecondary institutions and their affiliated research hospitals and institutes with the expenses associated with managing the research funded by the three federal research granting agencies.

The Research Support Fund is a tri-agency initiative of the <u>Social Sciences and Humanities</u> <u>Research Council (SSHRC)</u>, the <u>Natural Sciences and Engineering Research Council (NSERC)</u> and the <u>Canadian Institutes of Health Research (CIHR)</u>. It is administered by the Tri-agency Institutional Programs Secretariat, which is housed within SSHRC.
